IF NOT PAID BY THE 26TH, SERVICE WILL BE DISCONNECTED. FULL BALANCE AND A \$25 RECONNECTION FEE PER UTILITY IS REQUIRED BEFORE SERVICES ARE RECONNECTED. ALL ACCOUNTS SENT TO COLLECTION WILL BE CHARGED AN ADMINISTRATIVE COLLECTION FEE. Payments can be made at the city office from 8:00 AM - 5:00 PM Mon-Fri or by using the drop box after hours.
